During the 6 month program, you will gain valuable hands-on experience in zoo wildlife care, working closely with experienced veterinary technicians, zoo veterinarians and zoo keeper staff. After the program, you will be better prepared to be competitive for other zoo veterinary technician positions. Please keep in mind that you may need to move around to find the right job. This program is open to post graduate, credentialed, experienced veterinary technicians only.



About Colorado Springs and Cheyenne Mountain Zoo

Cheyenne Mountain Zoo is located in Colorado's second-largest city, Colorado Springs. Nestled along the Front Range of the Rocky Mountains, and in the shadow of Pikes Peak, Colorado Springs offers all of the <u>resources</u> and <u>culture</u> of a much larger city, but with a <u>competitive cost of living</u>. <u>Outdoor adventure</u> is one of the best features of the area, with 375 miles of trails, 150+ parks and a climate that typically provides

Cheyenne Mountain Zoo, America's mountain zoo at an elevation of 6,714 feet above sea level, offers comprehensive education programs, exciting conservation efforts and truly fantastic animal experiences. It is Cheyenne Mountain Zoo's goal to help guests fall in love with animals and nature, and take action to protect them. Since 2008, CMZoo's Quarters for Conservation program has raised more \$4 million dedicated to frontline conservation efforts around the world. Of the more than 235 zoos and aquariums accredited by the Association of Zoos and Aquariums (AZA), Cheyenne Mountain Zoo is one of just a few operating without tax support. Cheyenne Mountain Zoo depends on admissions, membership dues, special event attendance and donations for funding.

About this Program

 Field and in-hospital immobilizations often include opportunities for intubation and anesthetic monitoring, IV catheter placement and maintenance of patient fluids, phlebotomy, drug administration, and diagnostic imaging. Procedure set-up, break-down, and post-procedure cleaning are also a part of each immobilization.



- In-house laboratory work. Running fecal parasite checks, performing manual WBC counts and differentials on birds and reptiles, using in-house lab machines, and prepping lab samples for send out to referral labs.
- **Daily duties** include daily upkeep and cleaning of the veterinary hospital, record keeping using ZIMS, filling and delivering prescriptions, care for hospitalized patients including the occasional neonate, wrapping and sterilizing packs, other duties as assigned by staff veterinarians and veterinary technicians.
- Training opportunities with our zookeeper staff may include participation in voluntary blood collection & plasma banking, voluntary radiographs, awake blood pressure measurements, vaccine/drug administration, and physical exams, all using trained behaviors.

Eligibility requirements

- Graduate of an AVMA accredited veterinary technology program.
- Must have a minimum of 2 years clinical work experience as a full time licensed/registered/certified technician with a strong knowledge of veterinary principles.
- Must provide a copy of a valid driver's license, have a clean driving record to be able to drive zoo vehicles and proof of valid health insurance.
- Motivated, able to work well alone and in teams, eager to learn new skills and make the most of their program experience.
- Must be able to lift 50 lbs., climb in and out of the vet van, remain bending/standing/ stooping for long periods of time, and work in adverse weather conditions.
- Must be legally able to work in the United States (US Citizen, Permanent Resident, or hold an Employment Authorization Document)

- Candidates will be required to work Thursday- Monday and be flexible with other days in case coverage
 is needed or cases happen on your days off. A typical work week is 40 hours per week, from 8:15-5:15
 pm with a 1 hour lunch. You would know well in advance of scheduling changes.
- Candidates will have a modified schedule for the first 2 weeks to train with the staff veterinary technicians. The training weeks will be Sunday-Thursday from the hours of 8:15 am 5:15 pm.
- Once fully trained and oriented, you may be expected to serve as the only veterinary technician with one of our veterinarians on occasion.
- Candidates may obtain outside employment but need to remain flexible for scheduling changes, as this
 internship is their primary job. Other employment outside the Organization must not interfere with your
 program's commitments, or involve a conflict of interest, or give that appearance. Local veterinary relief
 work may be an option if you are licensed in Colorado.
- Candidates must have a personal vehicle for this program.

Compensation and Benefits

- Compensation will be a stipend of \$1300 at the end of each month. You will be required to fill out a I9 since this is a contract position.
- No additional benefits will be provided and candidates will be required to provide proof of personal health insurance.
- CMZoo veterinary technicians may be willing to allow the post-graduate to flex/shift work and personal days with prior approval. Excessive flexing/shifting out of the primary Thursday- Monday schedule is prohibited.
- Time off may be approved by the hospital manager with advance notice and should not be longer than a
 week in time combined.
- Uniform shirts, outerwear and name tags will be provided. Full dress code for CMZoo ("Zoo Crisp") will be provided before the program begins. Uniforms are returned clean at the end of the program.
- As a zoo "intern" you will get 50% off food/drinks at our restaurants as well as 20% off in the gift shop.

Housing

- Housing is provided on zoo grounds and is free of charge for post grad veterinary technicians in this
 program. There is a 2 bed/1 bath veterinary student/veterinary technician post-graduate apartment within
 a quick 1 minute walk from the veterinary hospital.
- A rental agreement will be provided and need to be signed before taking occupancy to cover liability concerns, expectations with occupancy and state of the used bedroom and common space upon leaving.
- Candidates will be sharing the apartment with rotating 4th year clinical veterinary externs, they are
 usually here from 2- 4 weeks and may be of any gender. They will have undergone a criminal
 background check before arriving.
- Apartment has a full kitchen including all cookware, a stocked bathroom with towels, and the bedrooms
 have full linens with spares to change out. The apartment has heating and a window AC unit, a full-sized
 fridge, stove and microwave as well as a few other kitchen appliances. Groceries are your own
 responsibility.
- No guests will be allowed unless there is no vet extern student and receiving prior approval from the hospital manager. Guests would only be allowed to stay a maximum of 2 consecutive nights.
- No pets allowed.

• Living off-grounds is allowed, but will not be financially provided for.









Required Application Materials

- To apply for this position, please send a resume and letter of interest to vetstaff@cmzoo.org, addressed to Brenda Cordova, Hospital Manager.
- Three references must also be submitted, names with email addresses and phone numbers are preferred.
- Indicate if wanting the program starting May-Oct or Nov- April
- Applications close in February for a May start date and in August for a November start date.
- Candidates will be notified via email within 1 week after applications close to schedule an interview.
- Program dates will be discussed during the interview.
- If selected, there is a \$50 background check fee.
- If selected, you will have to register with DORA and be licensed in Colorado.
- Interview process will include a Zoom interview with veterinary staff members.
- Final acceptance into this program is contingent upon the background check.
- Accepted candidates must provide proof of personal health insurance before starting.
